Announcing the results of the 2023 New England Thunderbolt Prize for Crime Writing

The New England Writers' Centre (NEWC) is delighted to announce the results of the 2023 New England Thunderbolt Prize for Crime Writing. The Thunderbolt Prize is a national award for unpublished short-form crime writing in three main categories: Fiction, Non-Fiction and Poetry. There are also three special awards: New England Award for a writer resident in New England; Emerging Author Award, for an unpublished writer over 18; and Youth Award, for writers under 18 years.

The competition is managed and promoted by the New England Writers' Centre and supported by New England businesses. New England Award: Jann Karp (NSW) for A Country Phone Call.

Emerging Author Award: Emma Andrews (NSW) for They Came to Watch Mrs Monty

Youth Award: Violette Amouroux (NSW) for The Lacquered Box.

Now in its 11th year, the Thunderbolt Prize for Crime Writing continues to attract a strong field of entries from all over Australia, by writers both published and unpublished. The NEWC is particularly excited to see students from a wide variety of schools, from all over Australia, submitting to the Youth Category.

The New England Writers' Centre warmly congratulates all the winners and commended writers. A full list of prize winners and commended titles is attached.

Our esteemed judges this year were: Ashley Kalagian Blunt (Fiction); Tony Maniaty (Non-Fiction); Jamie Grant (Poetry), and Judith Rossell (Youth). All entries were judged anonymously, and the New England Award and Emerging Author Awards were chosen based on final commendations across all categories. The winning entries, together with our judges' reports, are published on the NEWC's website.
